**NOW THEREFORE**, I, Shri Surendra Kumar Meena, IAS, District Magistrate, Alipurduar, being authorized under the Act and statutes, do hereby de-notify the above **BROAD BASED CONTAINMENT ZONE Areas** from being so identified and do **declare** the same areas as **Category C (Clean Areas)** as defined in no. 177-CS/2020 dt. 18/05/2020 and as per Memo no. H&FW/176/20 dt. 01/06/2020 with a further direction to the incident Commander for implementing field Surveillance for a further period of 14 days with necessary assistance from all concerned agencies / organizations/ individuals including the Health and police Establishments.
