ORDER

WHEREAS, Chiranjit Sarkar, WBCS (Exe), Block Development Officer, Alipurduar-II & Incident Commander has recommended vide Memo no. 1055/APD-II/2021, Dated- 08/07/2021 for de-notifying the above containment Zones and Buffer Zones;

AND

NOW THEREFORE, I, Shri Surendra Kumar Meena, IAS, District Magistrate, Alipurduar, being authorized under the Act and Statutes, do hereby **de-notify** the above **Micro Containment Zones** as defined in No. 177-CS/2020 dt. 18/05/2020 and as per Memo No. H&FW/176/20 dt. 01/06/2020 with a further direction to the Incident Commander for implementing Field Surveillance for a further period of 14 days with necessary assistance from all concerned agencies / organizations/ individuals including the Local Health and Police Establishments.

This Order is issued with immediate effect until further Order.
