NOTIFICATION

Whereas many persons from GP: Birpara-I, Madarihat, Madarihat Block area falling under the District of Alipurduar reported as COVID-19 positive on 04/08/2020.

&

Where, as per Order Vide Memo no. 177-CS/2020, dated 18/05/2020 of the Chief Secretary to the Govt. of West Bengal and subsequent SOP regarding Containment Zones vide memo no. H & FW/176/20, dated-01/06/2020 of the Principal Secretary, Department of Health & Family Welfare, Government of West Bengal, read with Order No. 40-3/2020-DM-I(A), dated-17/05/2020 of Government of India in the Ministry of Home Affairs, the area in which this confirmed COVID case resided before the detection, are required to be declared as Containment Zone and special steps are to be taken for containment of further spread of infection.

&

Whereas, as per memo no. 351/HS/PA/20, Dated-07/07/2020 of the Addl. Chief Secretary & Chairman, Enforcement Task Force, the current Containment Zone combined with current Buffer Zone, together constitute a revised Broad-Based Containment Zone.

Hence, as per prescribed parameters as stated in above order, the area is hereby declared as **BROAD-BASED CONTAINMENT ZONE** as stated in the following table. CMOH, Alipurduar is to take up all health related containment measures in these areas and as per the existing guidelines. Superintendent of Police, Alipurduar is also requested to take up all measures for effective enforcement of the containment steps.

Madarihat	Birpara- I Gram Panchayat (Whole)	All surrounding areas except areas notified herein are not under containment/ lockdown

The orders issued vide memo no: 337/2020 dated 04/08/20, 301/2020, 302/2020 dated 30/07/20, 265/2020 dated 22/07/20, stands cancelled. Now the whole Gram Panchayat area of Birpara I shall be treated as one broad based containment zone & The BDO Madarihat – Birpara-I shall ensure home delivery of essential services as far as practicable in the containment zone. Norms of Physical distancing, wearing of masks, health and hygiene protocol must be strictly adhered to at all times.

This Order will take immediate effect and remain in force until further order.
