Sealed quotations are hereby invited from the reputed and bonafide dealers/suppliers on their respective letter head who have previous experience of supplying material to a Govt. Organisation/office. Interested quotationers will have to submit up-to-date copy of P.T.C.C., I.T., VAT certificate, Trade Licence, PAN card along with the quotation papers. The rates will have to be quoted for all the individual materials as specified in annexure – I given below.

The quotation papers will be received till 23.03.2018 up to 02:00 P.M. from the date of publishing of this NIQ and will be opened on the same day at 04:00 P.M at the chamber of Additional District Magistrate(G) Alipurduar. Intended quotationers may remain present at the time of opening the box.

The following are the terms and conditions for the quotationers :-

1. An earnest money of Rs. 10,000.(Rupees ten thousand) only will have to be deposited in from of DD/Bankers Cheque in favour of the District Magistrate, Alipurduar and the same should be enclosed along with the quotation papers. This earnest money will be considered as the security deposit for the successful quotationer.
2. Quotationers must hve previous experience certificate for supply of similar items. Only those quotations with valid credentials will be accepted.
3. The quotationers will have to provide detailed brochure of the quoted items in a separate sealed box as mentioned in the attached annexure-I. Failing which may lead to disqualify himself/ herself from the process of this quotation.
4. The quotation with the overall lowest rate of items quoted only will be accepted.
5. The materials should be supplied immediately within 12(twelve) working days after issuance of supply order from this end, failing which the security money will be forfeited and supply order would be given to the next second lowest quotationer, with or without prior notice.
6. The sealed quotations should be dropped in the drop box, which will be kept at the chamber of the NDC, District Magistrate Office, Alipurduar on all working days within office hours up to P.M. on Quotations will be rejected straightway, if received through any other way.
