**NOTIFICATION**

Whereas one Person from Subhashpalli (North) under GP: Birpara-I (Part no. 14/135 partially), Madarihat Block area falling under the District of Alipurduar reported as COVID-19 positive on 11/07/2020.

&

Where, as per Order Vide Memo no. 177-CS/2020, dated 18/05/2020 of the Chief Secretary to the Govt. of West Bengal and subsequent SOP regarding Containment Zones vide memo no. H & FW/176/20, dated-01/06/2020 of the Principal Secretary, Department of Health & Family Welfare, Government of West Bengal, read with Order No. 40-3/2020-DM-I(A), dated-17/05/2020 of Government of India in the Ministry of Home Affairs, the area in which this confirmed COVID case resided before the detection, are required to be declared as Containment Zone and special steps are to be taken for containment of further spread of infection.


Whereas, as per memo no 351/HS/PA/20, Dated-07/07/2020 of the Addl. Chief Secretary & Chairman, Environment Task Force, the current Containment Zone combined with current Buffer Zone, together constitute a revised Broad-Based Containment Zone.

Hence, as per prescribed parameters as stated in above order, the area is hereby declared as **BROAD-BASED CONTAINMENT ZONE (in Category A and B)**, as stated in the following table. CMOH, Alipurduar is to take up all health related containment measures in these areas and as per the existing guidelines. Superintendent of Police, Alipurduar is also requested to take up all measures for effective enforcement of the containment steps.
