NOTIFICATION

Whereas Some persons from Ward No: X, Alipurduar Municipality area falling under the District of Alipurduar report as COVID-19 positive on 28/12/2021.

Where, as per Order Vide Memo no. 549-CS/2021, dated 15/06/2021 and 177-CS/2020, dated 18/05/2020 of the Ch Secretary to the Govt. of West Bengal and subsequent SOP regarding Containment Zones vide memo no. H FW/176/20, dated-01/06/2020 of the Principal Secretary, Department of Health & Family Welfare, Government of W Bengal, read with Order No. 40-3/2020-DM-I(A),dated-17/05/2020 of Government of India in the Ministry of Ho Affairs, the area in which this confirmed COVID case resided before the detection, are required to be declared Containment Zone and special steps are to be taken for containment of further spread of infection.

Hence, as per prescribed parameters as stated in above order, the area is hereby declared as MIC CONTAINMENT ZONE as stated in the following table. CMOH, Alipurduar is to take up all health related containm measures in these areas and as per the existing guidelines. Superintendent of Police, Alipurduar is also requested take up all measures for effective enforcement of the containment steps.

This order shall remain in force till 17 days from the date of sample collection and shall be automatic withdrawn in the event of no fresh cases in the locality.
