**ORDER**

**WHEREAS**, Containment Restrictions were imposed under Section 34 read with Section 26 of the Disaster Management Act 2005 and in compliance with the provision laid down in No. 177-CS/2020 dt. 18.05.2020 of the Chief Secretary, Govt. of West Bengal in the Notified areas as mentioned in the below:

**WHEREAS**, no new cases has been reported from the above areas since the Notification of the Containment Zones and all restrictions and containment measures in terms of extant Government Orders to prevent the spread of COVID-19 have been taken including strict perimeter control except for emergencies and maintaining supply of essential goods & services;

**AND**

**WHEREAS**, multidisciplinary teams have ensured intensive Lockdown Surveillance, delivery of essential commodities, intensive Contact Tracing, House-to-House Surveillance, other clinical interventions and testing in the Containment Zone for effective implementation of all restrictions and containment measures;

**AND**

**WHEREAS**, no new ILI or SARI cases have been reported in the above areas in this entire duration;

**AND**

**WHEREAS**, Shri Shrinivas V. Patil, IAS, Block Development Officer, Alipurduar-II & Incident Commander has recommended vide Memo no.808, Dated-22/06/2020 for de-notifying the above containment Zones and Buffer Zones;

**AND**

**NOW THEREFORE**, I, Shri Surendra Kumar Meena, IAS, District Magistrate, Alipurduar , being authorized under the Act and Statutes , do hereby **de-notify** the above **Category A/ Affected Areas(Containment Zones)** and **Category B/ Buffer Areas** from being so identified and do **declare** the same areas as **Category C ( Clean Areas)** as defined in No. 177-CS/2020 dt. 18/05/2020 and as per Memo No. H&FW/176/20 dt. 01/06/2020 with a further direction to the Incident Commander for implementing Field Surveillance for a further period of 14 days with necessary assistance from all concerned agencies / organizations/ individuals including the Local Health and Police Establishments.

This Order is issued with immediate effect until further Order.
