NOTIFICATION

Whereas one person from New Town, Kalakakoli School Lane, (Part No. 12/189 partially) of Ward No. 02 under Alipurduar Municipality area falling under the district of Alipurduar reported as COVID-19 positive on 03.06.2020.

&


Whereas, as per Order vide Memo. No. 177-CS/2020, dated 18/05/2020 of the Chief Secretary to the Govt. of West Bengal and subsequent SOP regarding containment zones vide memono. H&FW/176/20, dated 01/06/2020 of the Principal Secretary, Department of Health & Family Welfare, Government of West Bengal, read with Order No. 40-3/2020-DM-I(A), dated 17/05/2020 of Government of India in the Ministry of Home Affairs, the area in which this confirmed COVID case resided before the detection, are required to be declared as Containment Zone and special steps are to be taken for containment of further spread of infection.

Hence, as per prescribed parameters as stated above order, the area is hereby declared as CONTAINMENT ZONE, divided into different categories, as stated in the following table, CMOH, Alipurduar is to take up all health related containment measures, in these areas and as per the existing guidelines. Superintendent of Police, Alipurduar is also requested to take up all measures for effective enforcement of the containment steps.

Category	Areas
A. Affected Area (Containment Zone)	Area covering House of Kanika Sen at New Town, Kalakakoli School Lane along with House of Milan Ganguly & Nayan ganguly to the East and House of Dhiman Dhar Choudhury to the West. (Alipurduar Municipality, District: Alipurduar)
B. Buffer Zone	Areas falling under Ward No. 02 (Except partial area under New Town, Kalakakoli School Lane as mentioned in Category A) (Alipurduar Municipality, District: Alipurduar)

This order will take immediate effect and remain in force until further order.
