NOTIFICATION

Whereas One Person from Purba Majherdabri SC Pry. School (Southern Portion) under GP: Majherdabri (Part No. 11/264 partially), Alipurduar-II Block area falling under the district of Alipurduar reported as COVID-19 positive on 19/06/2020.

&

Where, as per Order vide Memo No. 177-CS/2020, dated 18/05/2020 of the Chief Secretary to the Govt. of West Bengal and subsequent SOP regarding containment zones vide memo no. H & FW/176/20, dated 01/06/2020 of the Principal Secretary, Department of Health & Family Welfare, Government of West Bengal, read with Order No. 40-3/2020-DM-I(A), dated 17/05/2020 of Government of India in the Ministry of Home Affairs, the area in which this confirmed COVID case resided before the detection, are required to be declared as Containment Zone and special steps are to be taken for containment of further spread of infection.

&

Hence, as per prescribed parameters as stated in above order, the area is hereby declared as CONTAINMENT ZONE, divided into different categories, as stated in the following table. CMOH, Alipurduar is to take up all health related containment measures, in these areas and as per the existing guidelines. Superintendent of Police, Alipurduar is also requested to take up all measures for effective enforcement of the containment steps.

Category	Areas
A. Affected Area (Containment Zone)	Purba Majherdabri SC Pry. School (Southern Portion) under GP: Majherdabri (Part No. 11/264 partially) (Block : Alipurduar-II, District : Alipurduar)
B. Buffer Zone	Areas falling under Sub Centre:Uttar Majherdabri SC (Except Part No. 11/264 partially as mentioned in Category A) (Block : Alipurduar-II, District : Alipurduar)

This order will take immediate effect and remain in force until further order.
