**NOTIFICATION**

Whereas one Person from Bidhanpally under Ward no: 09 (part no. 12/199 partially), Alipurduar Municipality area falling under the District of Alipurduar reported as COVID-19 positive on 17/07/2020.

&

Where, as per Order Vide Memo no. 177-CS/2020, dated 18/05/2020 of the Chief Secretary to the Govt. of West Bengal and subsequent SOP regarding Containment Zones vide memo no. H & FW/176/20, dated-01/06/2020 of the Principal Secretary, Department of Health & Family Welfare, Government of West Bengal, read with Order No. 40-3/2020-DM-I(A), dated-17/05/2020 of Government of India in the Ministry of Home Affairs, the area in which this confirmed COVID case resided before the detection, are required to be declared as Containment Zone and special steps are to be taken for containment of further spread of infection.

&

Whereas, as per memo no. 351/HS/PA/20, Dated-07/07/2020 of the Addl. Chief Secretary & Chairman, Enforcement Task Force, the current Containment Zone combined with current Buffer Zone, together constitute a revised Broad-Based Containment Zone.

&

Hence, as per prescribed parameters as stated in above order, the area is hereby declared as **BROAD-BASED CONTAINMENT ZONE (in Category A and B)**, as stated in the following table. CMOH, Alipurduar is to take up all health related containment measures in these areas and as per the existing guidelines. Superintendent of Police, Alipurduar is also requested to take up all measures for effective enforcement of the containment steps.

Category		Areas
BROAD-BASED CONTAINMENT ZONE	A. Affected Area	Area covering the house of Nepal Dutta to the house of Shyamal Karmakar in the South, from the house of Sunil Das to the house of Madhab Ghosh in the West, from the house of Kamal karji to Lebugagan School in the East, from the house of Dipak Mandal to the house of Mridul Roy in the North. ( Alipurduar Municipality, District: Alipurduar)
	B. Buffer Zone	Areas falling under part 12/199 except the area mentioned in category A. ( Alipurduar Municipality, District: Alipurduar)
