

- (1) The intending quotationer will have to submit valid relevant self attested X-erox copies as well as Original documents (For verification as and when required) of upto date License, P.T.C.C., PAN Card, GST certificate, Authorization Certificate (for authorized dealers only) etc. along with the quotation rate submitted by the agencies.
- (2) Details specification of items of work shall be provided in Annexure - A.
- (3) The bidders shall submit all technical papers, Earneast money, x-erox copy of PAN Card, GST certificate etc in **Cover 1 subscribing as Technical Bid** and the second cover i.e. **Cover 2** will contain the offered rate in the form of gross amount. The **Second cover** will be subscribing as **Financial Bid**.
- (4) Date of dropping of Quotation on **09.01.2020 upto 4.00 pm** and the technical bid will be opened at the same day at **4.30 pm** at the under signed chamber. Financial bid of technically qualified bidders will be opened on **10.01.2020 at 11.00 am**.
- (5) Quotation box will be kept in the Chamber of the Undersigned.
- (6) EMD amount should be deposited infavor of the **PO cum DWO, BCW & T.D Department, Alipurduar through DD/DCR/ Banker Cheque only**.
- (7) The rate should be inclusive installation, transportation, GST and other taxes, all necessary electrical works and plumbing works including a permanent water connection to the nearest running water source, 1 year warranty and 1 year free servicing. No separate payment will be made for those purposes.
- (8) No materials or any other work related tools and equipments will be issued by the department.
- (9) On receipt of the Clearance Notice from the Department, the supplier selected for the job will have to remove all the materials within 24 hours at his own cost and risk as well as the working site will have to be cleared up fully.
- (10) No damage/Lost or theft charges will be entertained.
- (11) The intending quotaioner(s) may remain present at the time of opening the Quotation.


