4. The Earnest Money Deposit (EMD) is equal to 2% (two percent) of the tender value amounting to Rs. 71,102/-only to be submitted through online. No tender will be accepted without receiving of Earnest Money Deposit.

5. **Eligibility criteria for participation in tender:**

The Application must be accompanied with the following documents.

Bonafide, resourceful contractor who have satisfactorily completed at least one similar nature of work (on building work) in each civil and electrical field as a prime agency in Government/ Semi-Government Dept./Parastatals having value of each civil & electrical works not less than 50% of tender amounts or executed two similar natures of works of 40% of tender amount

**N.B:- No credential will be considered unless it is supported by work order, payment certificate**

& as well as completion certificate clearly mentioning final billing amount, date of completion of work and details of communication address of the issuing Officer not below the rank of Executive Engineer or any officer of similar rank of the concerned department or any officer equivalent to the Engineer-in-charge of the work.

- a. Up to date Trade License.
  - b. Registration Certificate under Companies Act and Article of Association & Memorandum (if any).
  - c. Registered Notary Deed of partnership Firm (If partnership firm).
  - d. Power of Attorney for Partnership Firm/ Private Limited Company (if any).
  - e. Declaration regarding Structure and Organization duly signed by the applicant.
  - f. Sub contract will not be allowed.
  - g. Employee Provident Fund Registration Certificate and current Challan copy.
  - h. ESI Registration and current Challan copy / relevant document in favour of ESI exemption, if any.
  - i. Bank Solvency Certificate of the bidder shall be for any date within last 3 (three) months from date of issue of this tender. Bank solvency Amount is 75% of the amount put to the Tender **OR** One year bank statement authorized by bank.
  - j. Pan Card, Income Tax Return (Assessment year 19-20, 20-21 & one quarter of 21-22) , Professional Tax registration Certificate along with up to date Challan for the AY 21-22, GST Registration with up to date return (september,21) , Photo ID Proof for self identification to be accompanied with Technical Bid documents.
  - k. For electrical part of work the intending agency must have valid Electrical Contractors License with valid Electrical Supervisors' Certificate of Competency in parts 1, 2, 3, 4, 5, 11 or Equivalent National Supervisors' Certificate of Competency and sufficient amount credential of Electrical amount.
  - l. Undertaking on not being blacklisted by Govt/Semi Govt. officers/ Parastatals in a Rs 10 or above Non –Judicial stamp paper.
6. Any agency not holding such Electrical contractor license and Electrical Supervisors' Certificate of Competency may hire an Electrical agency, holding such license, certificate and required credential. Hired nature should be in notary agreement in Rs.50/- Non –Judicial stamp paper. (\*\* The prime agency must upload the said electrical documents and a declaration of not being blacklisted of hired agency).
7. Constructional Labour Welfare Cess @ 1 (one) % of cost of construction will be deducted from every Bill of the selected agency, GST & all other Statutory levy/ Cess will have to be borne by the contractor & the rate in the schedule of rates inclusive of all the taxes & cess stated above.
8. The Agency will be liable to maintain the work at working portion at the appropriate service level to the satisfaction of the Engineer-in-Charge at his own cost for a period of 12 months from the date of completion of the work, if any defect / damage found during the period as mentioned above Contractor shall make the same good at his own cost expense to the specification as per with instant Project work. Failure to do so, penal action against the agency will be imposed by the Department as deem fit. The agency will have to quote his rate considering the above aspect.
9. The bidder, at his own responsibility and risk is encouraged to visit and examine the site of works and its surroundings and obtain all information that may be necessary for preparing the bid and entering into a contract for the work as mentioned in the Notice Inviting Tender. The cost of visiting the site shall be at the bidder's own expense.
