

NOTICE INVITING QUOTATION (Re- NIQ)

The C.M.O.H & Member Secretary, District Health & Family Welfare Samity, Alipurduar hereby invites Re- Notice Inviting Quotation (Re-NIQ) in sealed envelope for hiring of 01 (One) four-wheeler Vehicle on hiring basis for the period of six months. The period shall be continued for six months from the date of issue of work order on hire basis in concurrence to memo no-HFW-27030/31/2019-NCDSEC Dept. of H&FW/MH/A-111 dated:22/12/2022 from ADHS Mental Health & SPO, NMHP, H&FW Dept, Govt. of West Bengal for mobility support of District Mental Health Programme, Planning Activity, Alipurduar.

Terms & condition:

1. The Four-wheeler vehicles must be Bharat Stage VI diesel engine driven Non AC Commercial Motor Cab (like Tata Sumo, Bolero or of similar make with engine capacity not more than 2000 c.c.), white or cream colour, preferably NEW or not more than three years old.
2. This NIQ of hiring the services of the Motor cab as per terms and conditions as mentioned in the schedule of Sl. No. 1, 2 & 3 of Transport Department's Notification No.3564-W173M-81/98 Dated-24.11.2008.
3. The vehicle should have commercial registration. Private vehicle owners can also apply subject to commercial registration of the vehicle within six months of issue of work order.
4. The vehicle should be provided with a driver having a valid driving license and driving experience of at least 03(three) years.
5. Vehicle must have FASTag compliant compulsorily. Toll tax amount if any (not penalty amount) will be reimbursed separately on production of actual toll tax payment receipt.
6. Hiring bill will be average 26 days per month or days of actual running which ever higher.
7. In case of new vehicle the bidder may submit his bid along with vehicle booking documents but he must ensure to place the same vehicle within 15 (fifteen) days of issuing work order if he gets selected as L1 (Lowest) bidder in the NIQ process.
8. The bid should be addressed to the CMOH, Alipurduar and should reach to the CMOH Office, Alipurduar by hand or by courier service or by speed post within at 05.00 pm on 08/02/2023. No bid documents will be received after the above date and time.
